GRAND COUNTY VOTERS APPROVED BALLOT ISSUE 1A LODGING TAX INCREASE FROM 1.8% TO 2% THAT WENT INTO EFFECT ON JANUARY 1ST OF THIS YEAR. THE INCREASE ONLY AFFECTS THOSE STAYING IN HOTELS OR SHORT-TERM RENTALS. PREVIOUSLY, LODGING TAX FUNDS COULD ONLY BE USED FOR TOURISM PROMOTION BUT THE APPROVED MEASURE ALLOWS UP TO 50% OF THOSE FUNDS TO OTHER ALLOWABLE USES, SUCH AS EARLY CHILDCARE. OUR COUNTY COMMISSIONERS VOTED IN FEBRUARY TO HAVE GRAND FOUNDATION DISTRIBUTE THOSE FUNDS THROUGH A FIELD OF INTEREST FUND. WE ARE EXCITED TO HAVE THE OPPORTUNITY TO APPLY FOR THESE ADDITIONAL FUNDS TO SUPPORT OUR SUSTAINABILITY.
